The formation of UNMC is in line with Uganda's broader agenda to drive industrialisation, job creation, infrastructure development and revenue mobilisation through effective and responsible exploitation of mineral resources such as copper, cobalt, gold, tin, rare earth elements, limestone and iron ore, among others. To lead UNMC into this new frontier,
